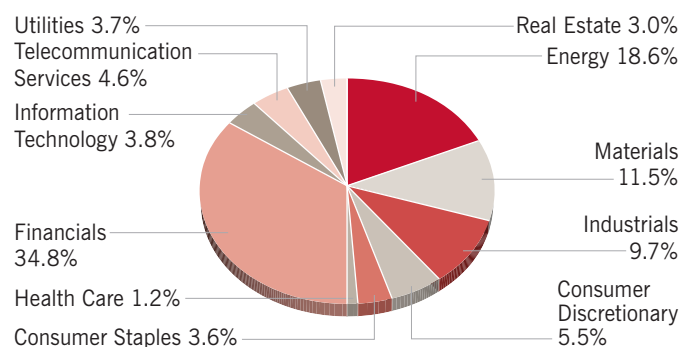

## INVESTOR PROFILE

Suited to investors seeking diversified exposure to the broad Canadian stock market, with a longer investment horizon to offset higher volatility of stocks.

## INVESTMENT OBJECTIVE

The objective of this fund is to:

- track the returns of the S&P/TSX Capped Composite Index
- outperform the average Canadian equity fund over the longer term after fees

## INVESTMENT STRATEGY

- BlackRock uses an “index” approach to manage this fund. The advantage of an index approach is that costs are generally lower, it provides broad diversification by investing in the largest public companies in Canada, and over time an index fund is expected to outperform the average active fund, net of fees and costs.
- To closely track the S&P/TSX Composite Index, BlackRock invests in all securities in the index very close to their actual index weights.
