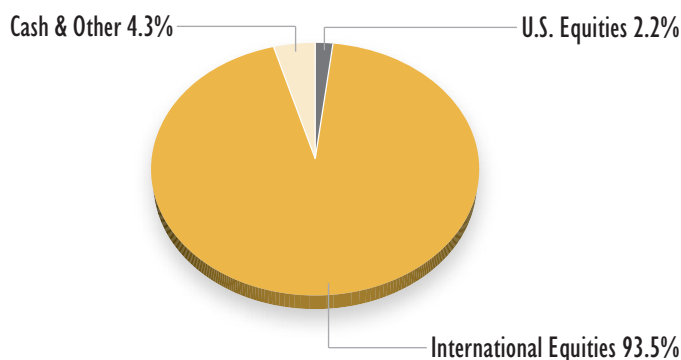


CUMIS International Equity Fund (Ethical)

INVESTMENT OBJECTIVE

The Fund aims to achieve long-term capital growth by investing primarily in equity and equity-related securities of companies located mainly outside of Canada and the United States. The Fund follows a socially responsible approach to investing.

INVESTMENT STRATEGY

- The fund invests in high-quality growth companies outside of Canada and the U.S. with an emphasis on bottom-up fundamental analysis.

The Ethical Funds Company focuses attention on a company's social, environmental, and human rights practices, and uses shareholder action strategies – proxy voting, shareholder resolutions and dialogue – to help them think for the long term.
