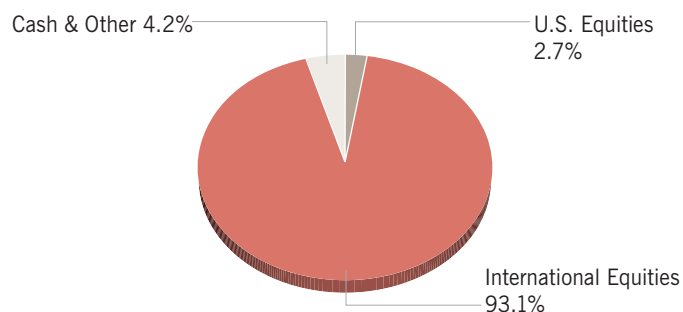


CUMIS International Equity Fund (Ethical)
