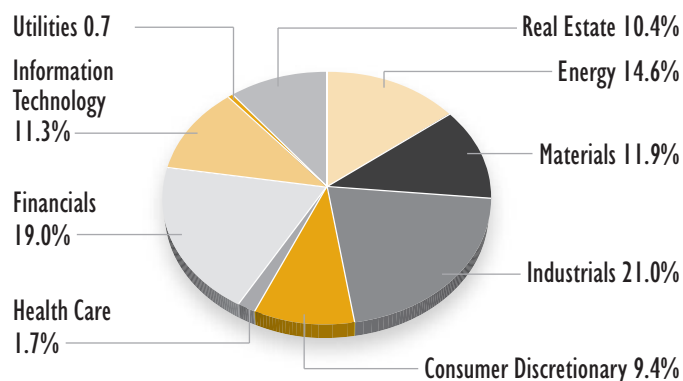


CUMIS Small Cap Canadian Equity Fund (Mawer)

INVESTOR PROFILE

Suited to investors seeking long-term, above-average growth, while tolerating significant volatility with higher risk.

INVESTMENT OBJECTIVE

The objective of the fund is to invest for above-average, long-term capital returns in securities of smaller Canadian companies, the securities of companies having special value, or the securities of companies having limited liquidity. Some selected companies in which shares may be acquired may be considered developmental.

INVESTMENT STRATEGY

- Many Canadian companies with less than \$500 million in capitalization or float offer excellent investment opportunities because they trade at a discount to their intrinsic value due to lack of coverage, unrecognized growth potential and other market inefficiencies.
- The portfolio managers use an entrepreneurial approach that combines bottom-up fundamental analysis with rigorous financial statement analysis to construct a broadly diversified portfolio based on company type, sector, geographic location and number of holdings.
